A word from the Director

INITIATIVES

The Covid-19 pandemic year of 2020 affected the activities of all of us. Its impact on UFMG and particularly on IEAT required work adaptations and adjustments of its several programs. Although IEAT had not interrupted its activities at any moment, its administrative work was transferred to the home office modality, and the visits and further on-site activities were interrupted or adapted to the virtual format. The intensive use of virtual platforms became a daily routine at the Institute.

The visits of professors planned for 2020 had to be suspended, thus, no new calls were announced for the 2020/2021 period. The Lecture Series CALAS/ IEAT took on a virtual character once its first lecturer, Prof. Roberto Briceño Leon, performed his activities virtually. Nevertheless, on-site activities are still foreseen for this professor in 2021.

The alterations of the academic calendar of 2020 caused adjustments during the period of activities of the resident researchers, which was extended until November. The programming of the event Intercontinental Academia was also altered, and its activities are now foreseen for 2021 and 2022. The stoppage of Imprensa Universitária (University Press) halted the publication flow of the IEAT Collection, organized together with Editora da UFMG (UFMG Publishing House).

In a scenario of altered routine, restricted access to equipment, and distanced from the University campus, the main activities developed were the following:

- •The program of Residents became more relevant to the Institute. With easier forms of external visitors' participation in seminars, now virtual, the residents organized a series of activities with the participation of guests, prominent in their respective areas as described in this report, transmitted to the academic and external communities. This required the important collaboration of CAC/UFMG (Community Issues Coordination). Seventeen online webinars took place, always with several hundreds of visualizations. Besides, scientific articles and other types of scientific production were published. One subject was lectured, open to undergraduate and graduate students, and the theme was Topics about Transdisciplinary Studies: Contemporary Questions of the Society and Territories. The course counted on the participation of the former IEAT professor, Prof. John van Breda, from the University of Stellenbosch (South Africa) in the Closing Seminar.
- Other four online seminars took place with the following partners: UFMG International Relations Board of Directors, UFMG School of Medicine, The New Coronavirus Confrontation Committee of UFMG, and the United Nations High Commissioner for Refugees (UNHCR) by the Brazilian branch of the International Law Association.

- Within the Lecture Series program CALAS-IEAT, the webinar entitled "The Neo-Institutionalist theories of crime and peace, and the crossbred modernity in Latin America", with the participation of Professor Roberto Briceño-Leon from CEA/UFC Advanced Studies College of the Federal University of Ceará and Laboratorio de Ciencias Sociales (Venezuela). A new call for applications for the Lecture Series program CALAS/IEAT was opened in November 2020.
- As for the Research Groups, only one was active until November 2020. Upon a qualified demand, the Directing Committee approved the expansion of the number of selected groups in 2020 from two to three vacancies. The groups began their activities in November 2020, and their main assignment in 2021 was the organization of a Seminar on Methodologies of Transdisciplinary Research in the pandemic context.
- ·Another text was selected for the publication in the book collection of IEAT: Information and the imaginary, result of interaction of researchers at UFMG, with Professor Armando Malheiros from the Porto University, an IEAT professor. Together with another two titles of previous years, they make up a waiting list for the Publishing House and the University Press activities return to normal; the latter was paralyzed due to the pandemic.

- · Another progress was the incorporation of the Revista da UFMG as a publication subordinate to IEAT. A new Regiment was approved, and a fully digital format was adopted, enabling periodicity to reach three annual numbers. Besides, there has been a recomposition of the Editorial Council and Commission, joining a significant number of external members to the university. Revista will now have an Executive Editor and an Executive Secretary. In 2020, volume 27, in its number 1, had "The transdisciplinary in the interfaces and interstices of the disciplinary" as theme, and for numbers 2 and 3, the theme chosen was "Disasters". This latter theme, under the responsibility of Professor Claudia Mayorga as editor, counted on 92 submitted articles, forcing the subdivision in two numbers.
- The Intercontinental Academia project, in its fourth edition, of the University Based Institutes of Advanced Studies network, had its format changed to begin virtually in June 2021. The headquarters in France also moved from Marseille to Paris. On-site meetings are being planned for October 2021 in Paris, and June 2022 in Belo Horizonte.
- Alterations in the operational structure of IEAT were discussed and sent as Regulation amendments for the appraisal of the superior authorities, including the creation of a communication sector, and the incorporation of substitutes in the Directing Council.

- The Graduate Program Vice-Presidency was also presented with the possibility of creation of interdisciplinary trajectories for graduate students, which was approved by the Graduate Program Vice-Presidency, and later on by CEPE in the Transversal Studies format.
- Two other initiatives were approved by the Directing Council for the year of 2021: the participation in the III World Congress of Transdisciplinarity, that began in December 2020 in the virtual format by means of the organization of the Symposium of Complexity and Humanism, that will take place in June 2021, and the offering of the discipline entitled "Knowledge Challenges" open to undergraduate, graduate and other interested persons, proposed by Professor Francisco César de Sá Barreto.

CHALLENGES

The main challenges for 2021, besides overcoming the pandemic, are to manage to incorporate learning into the distance activities caused by the pandemic to improve our activities in times of normality, besides the economic feasibility of the Intercontinental Academia 4 scheduled to take place on-site at UFMG in 2022. Other important goals are the consolidation and regularization of the publication flow of Revista da UFMG, and the implementation of the organizational alterations proposed in our structure, besides the search for new external partnerships to enable the lecture series.



IEAT in 2020

RESEARCH PROJECT Health and Human Resources Management Necessary interfaces and their effects on the services to the population

The project aims the discussion on Human Resources and their role in the context of Health, seeking the answer to the following questions: is there any work regime attractive to all professionals that would not affect health results, feasible from the public management perspective? What would be the most adequate working days for the teams acting in family health? Would it be possible to set a pact among the municipalities regarding health workers' management? How could incentive arrangements be structured in order to allow sustainable allocation of qualified human resources overtime? Are there any alternatives for the composition of payment that would articulate fixed and variable elements? Is it possible to manage the workers' performance through health outcomes? Ultimately, is it possible to assert to what extent health results undergo due influence of human resources management? From these reflections, the effort is to clarify the feasible ways and alternatives of human resources management in health that would effectively come up with profits to the assisted population.



RESEARCH PROJECT The exclusion system in the Brazilian neoliberal city

The project seeks to theoretically and empirically articulate issues concerning the exclusion system in the Brazilian neoliberal city through transdisciplinary dimensions responding to the following core question: who controls the city, who benefits from what, who does the city oppress or violate, and underpinned by which practices – aligned to the specific objectives in each field of knowledge: (i) Architecture and Urbanism, exposing the forces present in the social, political and economic relations between individuals and groups, and connect them to the forms of life in the city; (ii) Geography, exposing the territories under the logic of condominial private property; (iii) Law, exposing the encrypted information of urban legislation that sets forth and manipulates statements as true by the building of rules, narratives and practices;(iv) History, exposing the standards of coloniality power that emerges as a result of colonialism; (v) Psychology, exposing the violent and oppressing psychological processes imposed to those who do not fit to the conditions ruled by the State-Capital association.

RESEARCH PROJECT The exclusion system of the Brazilian neoliberal city

In the last decades, there has been an unprecedented rise of the number of infections by viruses carried by vector mosquitoes, the so-called arboviruses, including those of Dengue, Zika and Chikungunya. The Dengue virus itself is nowadays responsible for ca. 400 M new human infections yearly all around the world. The number of annual cases of the disease increased over 30 times in the last 50 years. Between 2013 and 2016, Brazil presented an average of over 1 M cases yearly of patients with Dengue. This situation is worsened by the absence of vaccines and effective treatments against the major part of the arboviruses, including Dengue, Zika and Chikungunya. These viruses are borne by Aedes sp gender mosquitoes, and the vector insect is one of the main targets for the prevention of epidemics. Strategies of population control have been broadly used from the simple use of insecticides to the liberation of radiation-sterilized or genetically modified mosquitoes. Nevertheless, the population control must be continually used and, when its reduction is incomplete, its real impact on transmission of the arboviruses is still uncertain. The natural resistance to the arbovirus infection, such as the Dengue virus, is widely documented in Aedes aegypti mosquito populations, and there are great interpopulation and intrapopulation variations. The knowledge about the natural resistance mechanisms could be explored for the strategic development of intervention in mosquito populations as a way to interfere or even block the vectorial transmission. Our hypothesis is that the differential expression of genes observed among individuals of a same population will explain the variation in resistance to the infection of the Dengue virus observed in A. Aegypti mosquitoes. In this project, we apply the multidisciplinary and transdisciplinary strategies focusing Bioinformatics analysis and state-of-the-art genic engineering to fight the vector transmission by arboviruses.





RESEARCH PROJECT The representation of refuge and immigration in media and its effects on a hosting policy in Brazil

The way media represent immigrants and refugees plays an important role in the perception and reception of this group in the hosting country. Immigration and refuge are generally situations forced by adverse conditions such as wars, religion or meteorological phenomena, and these groups need protection and integration in their new countries. The number of forced displaced persons is estimated to reach ca. 70 million worldwide, according to data of the United Nations High Commissariat for Refugees (UNHCR) of 2019, of which 25 million are refugees. Besides the refugees from Venezuela – in August 2018, the number of Venezuelan refugees in Brazil had already surpassed the number of Syrians – those from Cuba, Angola, Syria and Congo, in addition to a considerable group of immigrants coming from Senegal and other African countries, Brazil configures a forced South-Southwards displacement.

The present work seeks to problematize the online media gaze on immigration and refuge within a debate on the theme from an interlinguistic perspective of the studies of metaphor by means of an analysis of metaphorical frames used in online newspapers. The objective of this study is to map how the refuge and immigration situation is represented by means of metaphorical frames in the Brazilian online media, in the case of Folha de S. Paulo, and in the North-American online media, in the case of the New York Times. The analyzed period covers the years 2015 and 2018. With these data, we intend to compare these metaphorical uses and their implications. Some questions that we try to answer are: what frames arise from the American and Brazilian media, taking the examples of the New York Times and Folha de S. Paulo, in order to represent the arrival of refugees and immigrants in the studied period? What metaphorical frames are employed to represent refugees and immigrants in the online media? What are their implications? From these questions, we seek to analyze how such categories make up the immigrant's and refugee's image in the USA and Brazil, and at the same time, what consequences the dissemination of given metaphors may have for this group's hosting in Brazil.



RESEARCH PROJECT Technological approaches to restrain disinformation, manipulation, and extremism in digital platforms

The American elections in 2016 and the Brazilian elections in 2018 called into question the belief that social networks came to bring the libertarian ideal and democratization. The social media became the stage for a true information war in electoral times. As social media are an ambiance where people influence and are influenced, there is a large space on these platforms for an abusive political marketing to take place. In the USA, the political marketing strategies abusively used propaganda propelled in Facebook, and turned the American elections political debate into a true chaos. In Brazil, the biggest event took place through WhatsApp. The quick diffusion and broad information propagation are social network features that may be abused in uncalled-for propaganda, interruption of legitimate communication, or even the execution of opinion manipulation campaigns through these platforms. Social media have been a fertile ground for the spread of hoax or slander, and little is known of the credibility of the information that is published in these systems. In this context, this project presents a proposition to mitigate this serious problem seeking transparency in the political campaigns performed in social media. Thus, our main objective is to provide technological solutions able to give transparency to political campaigns through social media. By collecting great databases and monitoring media such as Facebook and WhatsApp, we intend to understand how the disinformation campaigns act in Brazil.



RESEARCH PROJECT Miscegenation, genomic diversity and complex diseases in Brazil

The project involves a series of publications and activities leading to a comprehension of the interbreeding process and its dynamics in Brazil and Latin America, considering its biological and cultural aspects besides the implications in people's health. The objectives initially proposed were: a) in the genomic epidemiology: from the mixed nature of the Brazilian population, we will carry out the admixture mapping (AM) of the body mass index (BMI) using the definition of overweight and obesity; b) in the area of genetics of populations: develop an X-chromosome-specific methodology to infer the parameters of a demographic and population genetic model of the dynamics of Brazilian miscegenation, and of the associated sexual bias (defined as preferential couplings among predominantly European men, and women predominantly African or Amerindian), using the Approximate Bayesian Computation (ABC); c) in the area of Bioinformatics: continue the development and maintenance of new Bioinformatics concepts and tools as the Scientific Workflow of the EPIGEN-Brazil project, within a perspective that favors the transparency of the scientific process and the collaborative development and reproducibility of the obtained results.

DIGITAL PLATFORMS OBSERVATORY (DPO)

The Digital Platforms Observatory (DPO) seeks to collaborate to the comprehension of the phenomena of digital platforms trivialization and of the society and territory digitalization. The objective is to understand in a transdisciplinary manner the new sociospatial relations that are established in the different domains of collective life, such as space, economy, culture, collective and mental health, communication, education, among others. Beyond the particular collaborations given by each disciplinary area, there is a convergent question: the technique and the information as new forms of social performance in the current historical period.

The main cut of the project is the transportation and delivery private companies by applications that lead the so-called "uberization". This theme is the object of a covenant celebrated between the Labor Prosecutors Office of the 3rd Regional and UFMG (Covenant Term No.078/19-00). These corporations, mainly global, take on new hegemonies to the extent that they define the standards of the technical and computerized systems used. Thus, they condition the habits as they reach gigantic numbers of places, users and consumers, bringing to light new geopolitical themes wanting to be known, studied and debated.

WHERE HAVE YOU BEEN? TRANSDISCIPLINARY STUDIES OF UFMG FORMER STUDENTS

The general objective is to investigate the egressed students' theme from the articulation of researches made by eight groups of research from different Units at UFMG. It is important to highlight that each group keeps its independence and commits itself to transdisciplinarily build a complex approach to the theme of the egressed students. Thus, the group accepts and furthers the methodological and theoretical methodology diversity of investigations, regarding both egressed undergraduate and graduate students. The egressed students' follow-up allows the acquaintance of the professional trajectories, insertions and performances of the graduate, and allows the crucial information survey for the updating of the curricular matrices of the graduates' original courses as well. Within the scope of the undergraduate courses, it is noteworthy that the National System of Higher Studies Assessment (Sinaes) indicates the analysis of the egressed students as an important quality assessment tool of the Higher Studies Institutions (IES). In the Graduate Studies National Plan (PNPG 2011-2020), the Higher Studies Personnel Improvement Coordination (CAPES) points out that the egressed students monitoring is an excellent quality indicator of the Graduate Studies Programs. Our main expectation is our contribution to broaden the theoretical and practical framework of the egressed students' theme.

SOCIAL PRACTICES IN THE URBAN SPACE (PRAXIS)

PRAXIS (Social Practices in the Urban Space) is a CNPq research group based by the Project Department (PRJ) and by the Graduate Studies Program in

Architecture and Urbanism (NPGAU) of the School of Architecture at UFMG, with projects financed and/or supported by Fapemig, CNPq, Capes, PRPq and ProEx/UFMG, Ford Foundation and FUSP.

Since its creation in 2009, the PRAXIS-EA/UFMG group develops research, extension and education with a critical perspective regarding relations and forces constituting production practices in the urban space, with special attention to the action of urban planning and project, but working in the interface of these two fields and in the construction of transdisciplinary dialogues with other fields, among them Geography, Sociology, Economics, Law, History and Psychoanalysis.

That the urban space is a structured and structuring means holding a set of information (social, economic, cultural, territorial, environmental and political) that presents itself by means of practices, and therefore, is born from structural traces of society and from triggered strategies when agents make their choices, make their decisions, or struggle for individual and collective interests is assumed. It is about welcoming theoretical, methodological, empirical and propositional approaches that constitute the transdisciplinary critical thinking in distinct investigation aspects on the contemporary city: (1) conditions of the production processes; (2) instruments, mechanisms and languages of representation, interaction, reading, intervention and existence present in the self-built territories; (3) socioterritorial networks; (4) exclusion system; (5) state-capital association.

Specifically, in the interface between the planning field and the urban project, a theoretical-methodological alignment is taken into account, interested in the articulation between the analysis of the power relations that structure the planning practices and urban project, and the analysis of external determinations arising from the economic, political, cultural, environmental and institutional fields with two objectives: (a) understanding the crisis of the neoliberal city model and the way processes of enterprising and financing influence the urban planning and project, including the relational analysis of the great projects, of the urbanistic instruments, and of the technical-specialist production; and (b) advancing in reading the place and the construction of a fairer city by means of practices, instruments and tools of analysis, representation and intervention in the urban space.

EVALUATION IN HEALTH FROM THE TRANSDISCIPLINARY PERSPECTIVE

The Human Resources in Health Observatory of the School of Economic Sciences at UFMG is a space of debate and proposition enhancement for health in Brazil, emphasizing the Unified Health System (SUS) for its large scope and relevance, seeking to approach the evaluation in different conceptual and applied perspectives. This project presents the following premises:

- · The need for execution of encompassing and representative studies.
- The necessary comparative instrument to adjust situations and promote reflections on likely changes in the provision of services considering the identification of critical and/or sensitive points.
- The incorporation of new themes to the health debate taking into account the intertwining of interdisciplinarity and complexity, and the necessity of a new approach to complex issues by transdisciplinary solutions oriented to problems and solutions;

- The construction of databases that guide not only academic works, but also the search for solutions in the health management field;
- The necessity to establish interaction with different researches and research networks focussing health, both for the exchange of experiences and mutual learning, and for the development of common projects as well.
- Thus, given the multidimensional scope approached, this investigation that intends to cross economic results (efficiency) of effects/impacts (effectivity) and social results (quality, satisfaction and adequacy to the use of resources), to study different conceptual constructs and approaching methodologies will allow a more accurate understanding of the assessment considering the locus of each research and its diffusion in different contexts, with its specificities and idiosyncrasies.


